# Background

[1] This Ombudsman report (Certification Report) arises from three *Ombudsman Act* complaints concerning the Human Rights Commission's (HRC) investigative and settlement processes.<sup>1</sup>

OMB-INV-2023-047

[2] On May 27, 2021, my office received a fairness complaint about the HRC alleging unreasonable delays in resolving the matter before it (*i.e.*, +two years), evidence mismanagement (*i.e.*, lost and found evidence) and questionable employee conduct in treating the complaint as being guilty from the outset. I assigned it to my Informal Case Resolution team.

[3] On February 10, 2023, I escalated it to Formal Investigation.

OMB-INV-2023-02-048

[4] On March 22, 2022, my office received a fairness complaint about the HRC alleging unreasonable delays in resolving the matter before it (*i.e.*, +16 months since HRC complaint submitted and no investigator assigned). I assigned it to my Informal Case Resolution team.

[5] On February 10, 2023, I escalated it to Formal Investigation.

OMB-INV-2023-04-084

[6] On March 10, 2023, my office received a fairness complaint about the HRC alleging that the settlement process used by the HRC between 2019-2022 concerning the complainant's matter was unfair. I assigned it to my Informal Case Resolution team.

[7] On April 12, 2023, I escalated it to a Formal Investigation as a matter to be investigated in tandem with files 047 and 048.

[8] A formal investigation report on these three complaints will be released publicly and tabled in the Yukon Legislative Assembly, independent of this Certification Report.

## Investigations

[9] As part of my investigations into these three complaints, it became necessary to determine if the common cause of the complaint issues pertaining to the HRC investigative and settlement

processes was due to a growing disconnect over time between the fiscal resources that the HRC requires to carry out its mandate and those resources annually allocated to it.

- [10] Although the HRC reports directly to the Yukon Legislative Assembly (YLA), the YLA does not independently fund it. The HRC instead receives appropriated funding directly from the Department of Justice (Justice) because the HRC, for budget purposes, is a program function of Justice.<sup>2</sup>
- [11] As such, I issued an NTPR to Justice to produce these records, including any discussions concerning the annual HRC budget.
- [12] Justice responded by providing some records but 'certified' others in accordance with section 18 of the *Ombudsman Act*, thus refusing to provide these latter records.

# **Authority to compel Documents**

- [13] Section 16 gives me broad powers to access information, and it is at my discretion to determine what information, documentation, or evidence I seek.
- [14] Section 18 allows for the exclusion of information from my review by giving the Minister of Justice the ability to make a 'certificate' (Certificate). It is not a defined term, but Black's Law Dictionary characterizes 'certification' as the process of giving someone or something an official document stating that a specified standard has been satisfied.<sup>3</sup>

#### **Executive Council Proceedings**

18 If the Minister of Justice certifies that the entry on premises, the giving of information, the answering of a question, or the production of a document or thing might

- (a) interfere with or impede the investigation or detection of an offence;
- (b) result in or involve the disclosure of deliberations of the Executive Council; or
- (c) result in or involve the disclosure of proceedings of the Executive Council or a committee of it, relating to matters of a secret or confidential nature and that the disclosure would be contrary or prejudicial to the public interest,

the Ombudsman shall not enter the premises and shall not require the information or answer to be given or the document or thing to be produced, but <u>shall report the making of the certificate to the Legislative Assembly not later than in the Ombudsman's next annual report</u>. [Emphasis mine]

[15] Ombudsman legislation elsewhere in Canada and in other commonwealth countries confer similar certification powers on ministers of Justice or attorneys general.

### **Facts**

#### 2023

[16] On July 24, 2023, my office received a response from Ian Davis, Acting Deputy Minister of Justice, attached as 'Appendix, Document 1'. He requested clarification about the scope of the above mentioned NTPR, as well as a production deadline extension.

[17] On July 25, my office replied by providing further clarification, as well as an extension. The letter is attached as 'Appendix, Document 2'.

[18] On August 15, Justice provided my office with a package of responsive records, including a covering letter attached as 'Appendix, Document 3'. In this covering letter, Deputy Minister Mark Radke stated as follows:

The following records are being withheld as they fall within subsections 18(b) and (c) of the *Ombudsman Act*:

- Financial Management Board Submission; and
- Department of Management Board Submission Tracking.

[19] On August 17, my office sent a letter to the Minister of Justice asking for clarification on the extent of the documents being certified, as well as confirmation of certification by the Minister. The letter is attached as 'Appendix, Document 4'.

[20] On August 28, the Minister of Justice replied by letter and attached as 'Appendix, Document 5'. The letter confirmed that she had issued a Certificate in respect of my HRC investigations. The Certificate identified the withholding of two documents pursuant to subsection 18(c): 'Financial Management Board Submissions' (six pages), and 'Department of Justice Management Board Submission Tracking' (one page).

### Conclusion

[21] The Minister of Justice, under subsection 18(c), certified that the production of two records, if provided to the Ombudsman, might cause one of two possible outcomes. The first is one that results in or involves the disclosure of Executive Council proceedings, including those of an Executive Council committee, concerning secret or confidential matters. The second is one that amounts to a disclosure contrary or prejudicial to the public interest. As such, Justice did not have to provide these records to the Ombudsman.

[22] In exercising her certification power, the Minister did not clarify why the two records were classified as secret or confidential, or how disclosure to the Ombudsman would be prejudicial to the public interest.

[23] Despite the issuance of this Certificate and its possible effect on my investigations into the HRC, I was able to complete them to my satisfaction.

Thank you for your letter dated July 24, 2023. I am happy to elaborate on the three categories under which I have requested documents.

I am of the understanding that the Yukon Human Rights Commission (the "HRC") is funded under the umbrella of the Department of Justice ("Justice") to whom the HRC makes annual budgetary submissions and periodic supplemental budgetary submissions.

I am looking for any/all records Justice possess which document those requests, internal records which contemplate such requests, and records which document actual funds being disbursed to the HRC from Justice. For greater context I am seeking to establish timelines and histories about the finances of the HRC. In addition, we are looking to see what factors Justice considers when deciding to accept, reject, or modify HRC budget requests.

With regard to your request for an extension of time, the Ombudsman is prepared, on a one-time basis, to accept the above described records no later than August 15, 2023.
